CONDITIONS

This limited warranty shall be subject to the original owner complying with the following conditions:

1. The swimming pool shall be kept full of water at all times except for purposes for repair or maintenance not to exceed five (5) days.
2. The Paramount system shall be operated by the original owner with reasonable care and necessary maintenance.
3. Product registration must be completed within thirty (30) days of pool completion.

Paramount NOZZLE AND BODY, (EXCLUDING NEW GENERATION POOL VALET, POOL VALET RETRO, PRIVATE LABEL VERSIONS OF NEW GENERATION POOL VALET NOZZLES AND BODIES) ASSEMBLIES

LIMITED LIFETIME MANUFACTURERS WARRANTY

Paramount warrants to the original owner, materials and equipment to be free of defects for as long as original owner owns pool, determined under this warranty to be for the "Lifetime" ownership by original owner from date swimming pool is plastered or optional interior surface finish applied. The materials and equipment covered under the "Lifetime" warranty are the Paramount Nozzle and Body Assembly. (PVC plumbing installed, labor, material and all other work performed by contractors is not covered under Paramount's Warranty.)

LIMITED MANUFACTURERS 3-YEAR WARRANTY

Paramount warrants to original owner, materials, and equipment to be free of defects for a period of three (3) year from date of purchase. The materials, parts, and/or related component parts supplied or distributed by Paramount are covered under this three (3) year limited warranty. (PVC plumbing installed, labor, material and all other work performed by contractors is not covered under Paramount's Warranty.)

Paramount RDX, MDX-R3 ANTI-ENTRAPMENT VGB COMPLIANT DEBRIS DRAIN & SDX2 HIGH FLOW DRAIN LIMITED MANUFACTURERS 3-YEAR WARRANTY

Paramount warrants to original owner, materials, and equipment to be free of defects for a period of three (3) year from date of swimming pool start-up. The materials, parts and/or related component parts supplied or distributed by Paramount are covered under this three (3) year limited warranty. (PVC plumbing installed, labor, material and all other work performed by contractors is not covered under Paramount's Warranty.)

Paramount DISTRIBUTION WATER VALVE

LIMITED MANUFACTURERS 3-YEAR WARRANTY

Paramount water valve is warranted for a period of three (3) years to be free of manufacturing defects including wear and tear on product from date of pool start-up. This warranty applies to the original pool owner only. Replacement parts thereafter are warranted for a period of one (1) year.

Paramount DEBRIS CONTAINMENT CANISTER (DCC2) & EQUIPMENT SIDE DEBRIS CANISTER (EDC), Parascope, Paralevel, Paraskim Skimmers, MVFuse, MDX-R3 LIMITED MANUFACTURERS 3-YEAR WARRANTY

Paramount warrants to original owner, materials, and equipment to be free of defects for a period of three (3) years from date of swimming pool start-up. The materials and equipment covered under this three (3) year warranty is the Paramount DCC2, EDC Housing, Parascope, Paralevel, Paraskim Skimmers, and MVFuse. (PVC plumbing installed, labor, material and all other work performed by contractors is not covered under Paramount's Warranty.) The Paramount Canister Debris Containment Basket, Internal Canister Lid, and Top Deck Lid are covered for a period of one (1) year under this warranty.

OTHER RELATED SYSTEM PARTS, ANCILLARY PARTS AND REPLACEMENT PARTS LIMITED MANUFACTURERS 1-YEAR WARRANTY

Paramount warrants to original owner, materials, and equipment to be free of defects for a period of one (1) year from date of swimming pool start-up. The materials, parts and/or related component parts supplied or distributed by Paramount are covered under this one (1) year limited warranty. (PVC plumbing installed, labor, material and all other work performed by contractors is not covered under Paramount's Warranty.) Replacement parts are warranted for a period of (1) year from the date of purchase. Paramount warrants to the original owner a one (1) year limited warranty that the Paramount related component parts to be free of defects from the time of installation.

REPLACEMENT CONDITIONS

It is the responsibility of the pool owner to contact the original "Reseller" which includes the Pool Builder, Retailer, or Service Company to process the return of any defective Paramount Product. All return items must be accompanied by proof of purchase. The "Reseller" will contact Paramount for an RMA number, and return it to Paramount. The repaired or replaced Paramount item will be returned to the original "Reseller" freight collect. Labor to remove the defective item and reinstall the repaired or replaced item is the sole responsibility of the pool owner, as are all freight charges.

LIMITATIONS

No warranty extends to any part of the Paramount parts or components which is caused by any of the following conditions or events:

1. Defects or failures caused by abuse, lack of responsible care, lack of necessary maintenance, improper operation, vandalism, acts of God.
2. Damages or failures caused by abuse, lack of responsible care, lack of necessary maintenance, improper operation, vandalism, acts of God.
3. Paramount expressly denies any responsibility or liability for incidental or consequential damages arising out of, or as a result of, use or ownership of your Paramount parts or as a result of use or ownership of your Paramount parts or components, or other related products covered under this limited warranty.
4. Any defects caused by acts of God, such as storms, earthquakes, ground movement, or freezing, etc., that are beyond the normal conditions.
5. Installation of the Paramount System by non-authorized installer may render this warranty null and void.
6. Paramount does not warranty against product fading and/or discoloration.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you.

Implied warranties are limited in duration to the duration of the written limited warranty herewithin. Some states do not allow limitations on how long an implied warranty lasts, so the above limitations may not apply to you. This warranty give you specific legal rights, and you may also have other rights that may vary from state to state.
